Current Status Summary:

CAREER BACKGROUND:

Former chairman of National League for Democracy (NLD) Ahlon Township, Ba Myint was first arrested and sentenced in 1990 under Section 5 (j) of the Emergency Provisions Act, to four years with hard labour in Insein Prison. He was arrested for listening to foreign language broadcasts and passing on the information to his friends. (1 November 2007 - Irrawaddy)

He was arrested for the second time on December 19, 2004 for distributing human rights information leaflets. He was sentenced under Act No. 5/96 Chapter 2, Section 3 of the Law Protecting the Peaceful and Systematic Transfer of State Responsibility and the Successful Performance of the Functions of the National Convention against Disturbances and Oppositions. He was given the maximum sentence of 20 years imprisonment, but was released early under presidential amnesty on September 17, 2009.

Ba Myint's political activism continued in 2014 where he staged a number of solo protests. Two such protests led to his arrest in 2015. In February 25, 2015 he was sentenced to his first count of unlawful protest under Section

18. He received one-month imprisonment for marching with one other protester, San San Yn, from Sule Pagoda to the Chinese Embassy in Rangoon, in demonstration against Letpadaung Copper-mine scandal. As his march passed through 6 different townships, Ba Myint is facing multiple charges under Section 18. He was additionally sentenced to 3 months on April 29, 4 months with hard labour on June 19, 4 months on July 8, 4 months on July 10, and most recently, 4 months on August 20, 2015.

In addition to being sentenced for his solo protest on January 1, 2015, Ba Myint has also been sentenced with an additional charge of Section 18 from Kyauktada Township Court for organising a commemoration for the 26-month anniversary of the Letpadaung crackdown in November 2012. He was sentenced to four months imprisonment on July 8.

ARREST DETAILS:

2015: Ba Myint was arrested for a solo protest he staged against the Letpadaung Copper-mine

2004: Ba Myint was arrested in December 2004 with three other NLD members and one other political activist for distributing human rights leaflets. He was allegedly denied access to legal council and was not permitted to see family members. He was sentenced on June 13, 2005 to life imprisonment (20 years). He was released on September 17, 2009.

1990: Arrested for listening to foreign broadcasts on the radio, and distributing that information to friends.

DETAILS OF IMPRISONMENT:

2015: Sentenced to seven counts of Section 18 and imprisoned in Insein Prison.

2004: Imprisoned in Bamaw Prison under Act No. 5/96 Chapter 2, Section 3, and sentenced to life imprisonment. Released under Presidential Amnesty on September 17, 2009.

1990: Sentenced to four years hard labour to Insein Prison under Section 5 (j) of the Emergency Provisions Act. He was released in 1994.
