Judge Htin Lin Ko gave him a two-year sentence under Myanmar's disaster management law and one-year under a different section of the same law, but those sentences are to be served concurrently. The charges related to the chief minister's attendance of the opening ceremony of a Covid-19 awareness campaign in Mandalay two days before the February 1 coup. He also received two years under Section 505(b) of the Penal Code for incitement, a charge related to several statements issued by the NLD condemning the junta. A source familiar with the proceedings said Zaw Myint Maung would not have the days he had already spent in detention taken off of his sentence.
