The State Counsellor, Aung San Suu Kyi and President, Win Myint, who have been arrested since February 1, were both sentenced to four years imprisonment under Section 25 of the Natural Disaster Management Law and Section 505 (b) of the Penal Code, They were sentenced to two years for Section 25 of the Natural Disaster Management Law and two years for Section 505 (b) of the Penal Code. On January 10, State Counselor Daw Aung San Suu Kyi, who was already sentenced to two years imprisonment, was sentenced to another four years in prison. She was sentenced to two years in prison under the Export-Import Law for importing the walkie-talkies and one year under the Telecommunications Law for possessing them. The sentences are to be served concurrently. She also received a two-year sentence under the Natural Disaster Management Law for allegedly violating coronavirus rules while campaigning.
